

LICE POLICY

Friends of Camp Concord has a strict Lice Policy for the protection of all campers and staff. If your child has lice they are not able to be at camp.

If your child is determined within 48 hours of departure for camp to have having lice and you are not able to make arrangements for treatment, a refund will not be given. If you are able to notify the Youth Camp Coordinator 48 hours or more prior to bus loading, a 50% refund will be given.

We do a Lice Clearance Check the day of departure. We will have qualified nurses from Comb it Out checking ALL kids heads before they load the bus. This will be the final step before kids load on the bus. The clearance check may take place around other campers, but we will do our best to be discreet in the unfortunate incident that your child is harboring lice.

If, at check in day of camp, lice is discovered on a camper during the Lice Clearance Check before they board the bus, they will not be able to board the bus, but treatment options are still available to you at your cost and time. No refund will be given.

You may do a treatment either on your own or professionally, and then arrange your own transportation to Camp Concord. Once the camper arrives at Camp Concord, our camp RN will do another inspection to determine if your child is in fact clear of lice

Lice are not uncommon in any community, and treatment can occur quickly. The good news is there are plenty of ways to ensure your child is free of lice!

You can check your child's head for your lice on your own! There are plenty of online resources to help you determine if your child has lice or not. Please begin checking regularly 2 weeks prior to camp so you have plenty of time for treatment if they are found.

Here are some tips around lice and performing lice self-checks:

- >> An itchy scalp can be a sign that lice may be present.
- >> You may be able to see the lice, or nits, by parting your child's hair into small sections and checking for lice and nits with a fine-tooth comb on the scalp, behind the ears, and around the nape of the neck (it's rare for them to be found on eyelashes or eyebrows).
- Adult lice are no bigger than a sesame seed and are grayish-white or tan. Nymphs are smaller and become adult lice about 1-2 weeks after they hatch. If not treated, this process will repeat itself every 3 weeks or so.

Nits are very tiny, yellow, tan, or brown dots before they hatch. These are usually on hair shafts close to the scalp. They may look like dandruff, but they don't come off by brushing or shaking them off. They hatch within 1-2 weeks of being laid.

If you suspect lice, or would like a qualified person to inspect, we suggest Comb it Out in Concord. Their website is **combitout.com** and their phone number is (925) 849-6496. If they do find lice, they can treat immediately.

We will have qualified nurses from Comb it Out checking ALL kids heads before they load the bus. This will be the final step before kids load on the bus. The clearance check may take place around other campers, but we will do our best to be discreet in the unfortunate incident that your child is harboring lice.

For campers not taking the bus to Camp Concord, they are to immediately upon arrival at camp check in with the camp RN to receive a lice check. If lice are discovered, the child will be asked to leave and seek treatment and may return after treatment. The RN will then do another lice check. If the RN clears the camper, then the child may join the campers in their assigned cabin. If the RN does not clear you child they will need to seek treatment again until the lice check is cleared. You may do this as many times as you like, but treatment cannot occur at camp.

If a camper is found with lice while at camp

- >>> Parent/guardianswill be called and must pick up the camper within 8-hours of notification.
 - Parent/guardians are welcome to seek treatment off site and come back after treatment to be cleared by the RN. All of the campers clothes and bedding will need to be replaced with clean/new articles before rejoining the cabin.
 - If parent/guardians choose to remove the child from camp, no refund will be given.
- >>> The parent/guardians of the other campers in the cabin will be contacted and informed that someone in their child's cabin had lice. They will be encouraged to check their children's hair when they come home and treat them if necessary.
 - The camp RN will conduct daily checks on campers who shared the cabin.

Parent/guardians and campers should be aware of the following:

- >> Lice are generally not a health concern.
- >> Lice are treatable, though it can take a lot of work to eradicate them.

- >> Lice don't jump or fly—they crawl from one person to another.
- >>> Head lice are usually spread from head-to-head contact, though they can sometimes spread from sharing brushes, hats, or bedding.
- Head lice can be on your head, your child's head, or your spouse's head, but they won't affect your pets, and they can't "infect" furniture, bedding, or pillows. They cannot survive more than two days off the scalp. So, if your child has lice, do not panic!

Parents should talk to their camper prior to camp to help them understand how to avoid lice. Most importantly, tell them:

- Do not touch heads with other campers (often done to pose for photos).
- Do not share beds, pillows, hats, clothes, stuffed animals, brushes, or combs.

The discovery of lice can be very disconcerting, but remember, lice are simply an unfortunate part of community living, and even when proper steps are taken to avoid them, they can still show up. Many children who come home from camps with lice may have been the ones to bring them to the camp in the first place. Let's work together to minimize this nuisance by carefully checking campers before they come to camp. And then, hopefully, they will be able to not worry about them and have the time of their lives!
